Step 1: Open the tail gate and  
locate the two phillips screw  
and remove them.



Step 2: Pull the tail light off  
from the vehicle.



Step 3: Unplug the tail light  
wire harness.



Step 4: Take out the new Anzo  
tail light from the box.



Step 5: Plug in the tail light  
wire harness into the new  
Anzo tail light.



Step 6: Test all functions to  
make sure of proper  
installation before driving.
